MULTI-DESTINATION CLUBS Point-based and Week-Trade Systems

Multi-destination club gives access to several destinations and resorts without having to go through an external exchange company and pay exchange fees. Major multi-destination clubs are on a point based system that varies according to the size of the unit and the time of the year. Others are based on a traditional week system that trades internally. Both types of system allows you access to external exchange companies.

Some clubs offer a deeded membership which is perpetual and is assigned to a particular home resort within the club. Others offer a right-to-use lease in terms of 20, 30 years or more. In general, members pay a one-time, upfront fee and annual dues. In exchange, members receive access to a roster of high-end, luxury homes and/or hotels around the world. Dates and locations are flexible and availability comes generally on a first-come, first-served basis.

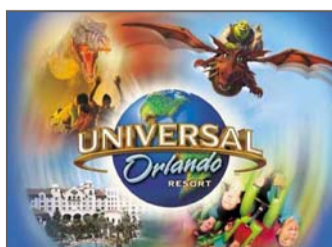
